# SUNDAY MORNING MEN INVITATIONAL LEAGUE RULES

## #1 League Management

The management of the league shall consist of the officers and the team captains. The team captains and the officers shall vote on league rules. Prior to the start of the season a simple majority vote can change or pass a league rule. Once the season starts a unanimous vote is required to change a league rule.

## #2 Franchise Fee

To obtain a franchise a **\$100.00** fee must be paid to the secretary. To retain the franchise for the next season, a retainer fee of **\$100.00** will be deducted from each team's prize fund at the end of the season. Failure to do so will not guarantee a franchise for the next season. The franchise fee will be forfeited to the league if for any reason a team drops out of the league.

## #3 Fees (Weekly & Sanction)

The amount to be paid by each bowler weekly shall be **\$30.00** of which **\$9.00** will cover the cost of bowling and the balance to go into the prize fund, less expenses. Each bowler will pay **31** weeks. The team captain is responsible for managing the team's pay envelope and ensuring the team and the individuals are current on league fees and dues.

No bowler will be allowed to bowl once he falls behind greater than four weeks (**\$121** or greater) in paying his weekly fees. A Team that falls behind greater than two weeks (**\$301** or greater) will forfeit all points each week until the outstanding past due amounts to two weeks (**\$300**) or less. Past due amounts are calculated prior to that given week. (i.e. if a team is exactly \$301 dollars behind going into a week, they will need to pay a minimum of the current weekly due (\$150) + \$1 to be eligible to win points for that week). Exceptions to this rule can only be granted at the discretion of the league board of directors.

Each individual bowler will pay the annual USBC sanction fee of **\$27.00**, which includes the *Suburban Windy City* local association. Each individual bowler must have his USBC dues by the 3<sup>rd</sup> week of bowling. After 9 games have been bowled, a bowler is only eligible to bowl once their USBC dues have been paid. A bowler failing to comply with this will result in his team having an illegal lineup each time that he bowls until his dues are paid in full.

## #4 High Score Prizes

To qualify for individual high game or series prizes a bowler must have 51 games bowled. A bowler or team can qualify for only one prize on one complete day of bowling. A bowler or team can win only one prize in each category. Handicap prizes start on the 7th week of the season.

## #5 Entering Individual Averages

Bowlers shall use the average maintained in this league last season based on 21 or more games. All others shall use their highest average from the previous season based on 21 or more games. If an individual did not bowl last year, we will go back up to 5 years to find their average. An average established in this league will take precedence over averages established in other leagues, even when the other league average is more recent. If an individual did not bowl in the last 5 years, they will receive an entering average of 175 and after 15 games will establish an average for the ten-pin drop rule. New bowlers using a *Standard* average from another league as the Entering average will have that average converted down to a *Challenge* average using the USBC conversion chart - <http://usbcongress.http.internapcdn.net/usbcongress/bowl/sportbowling/pdfs/SportChallengeStandardConversion.pdf> For example – a bowler coming in with a *Standard* average of 205 will use an Entering Average of 190.

## #6 Entering Team Averages

Maximum team average is 925. Team average is based on entering averages (see rule 5). If a bowler is added during the season the team average is based on entering averages, teams cannot exceed 925 when a new bowler is added. If a team exceeds 925 they will forfeit all points won. A one-year grace period will be provided for teams that finish the season exceeding the 925 maximum team average for bowlers on the team's previous season roster.

New teams entering the league that have *Challenge* averages exceeding 925 will be allowed in the league and will be immediately put on grace period. A new team is one that has a minimum 3 of the 5 regular bowlers without a previously established average in the Sunday Morning Mens Invitational.

## #7 Handicap

The handicap allowance is 90% and is figured on the difference between each average and 200 scratch, with a maximum of 60 pins. Handicaps like averages will be frozen for the first 6 games of the season, based on Entering Average. Ten-pin drop rule will apply to a bowler's Entering Average. New bowlers without an average for the last 5 years will receive handicap based on an average of 175 for their first 6 games. That bowler's average after 15 games will be used to establish their average for the ten-pin drop rule.

## #8 Team Rosters

Captains must turn in rosters to the secretary by the 2nd week of the season. Rosters will be limited to 8 bowlers. If a team uses a bowler's absentee score and said bowler does not join team the secretary shall change the absentee scores to the blind score of 150 and no handicap. The secretary will review wins and losses and change accordingly.

## #9 Blind Score

150 with 0 handicap.

## #10 Substitute Eligibility

Team captains shall notify the secretary of its designated 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> man, aka substitutes. A substitute cannot bowl the final week of the first third unless he has a minimum of 6 games, the final week of the second third unless he has a minimum of 9 games bowled. A substitute cannot bowl the final week of the final third nor any playoff round unless he has a minimum of 12 games bowled. If a substitute bowls and doesn't have the required games the penalty is a forfeit of all points won. A substitute cannot put the team average over the maximum of 925 unless that specific sub was on the roster in the previous season and is included 1 year grace period.

## #11 Legal Lineup and Forfeit

Bowlers from the team's current roster as well as the designated 6<sup>th</sup>, 7<sup>th</sup> or 8<sup>th</sup> man shall count toward a legal lineup. Three men are needed for a legal lineup and must be ready to bowl at the start of bowling. The start of bowling is 9:35am or when 1st ball is rolled for score, whichever comes later. In the event a team does not start with a legal lineup they shall forfeit the 1st game and the series point. In the event a team does not have a legal lineup for all three games the opposing team must bowl within 50 pins of their average each game to win the points. No points will be awarded to the team with an illegal lineup. Exceptions to the legal lineup rule can be made in cases of emergency, as stipulated in USBC Playing Rule 117.

## #12 Tardy Bowlers

Tardy bowlers cannot bowl after 5 complete frames of the 1st game and not after the 1st complete frame of the 2nd or 3rd games.

## #13 Bowling Out

A bowler can bowl out a maximum of the last 5 frames of the **last game only** with the consent of the opposing team captain.

## #14 Absentee Score

Absentee scores will be allowed when a team has a legal lineup but less than a full lineup at the start of any game. The absentee scores will be the average less ten pins of the absent bowler with the most games bowled. It should be noted that the average used for the basis of the absentee score will be the bowler's actual pin fall for all games bowled, known as the *Real Average*. The handicap used for the absentee score will be based off the bowler's *Average (subject to the 10 pin drop rule)*. The bowler to be used as the absentee bowler will be determined by having the most games bowled on the season to-date.

## #15 Position Standings

**30 Point system.** 9 total points are awarded for each game and 3 points are awarded for team series. All scoring includes handicap. The team bowling on the right lane will enter their lineup first, the team bowling on the left lane can then alter their lineup if they so choose to get the desired matchup.

Breakdown below:

- 1) **Individual head-to-head game w/handicap** (*1 point per individual matchup per game, 5 total points each game*)
  - Bowlers in corresponding positions in each team's lineup bowl head-to-head against each other each game w/handicap for 1 point each (Bowler 1 vs Bowler 1, Bowler 2 vs Bowler 2, etc) for a total of 5 points per game.
  - Individuals bowling against absent bowlers must win their head-to-head point by beating their opponent's absent score. If absent bowlers are matched up against one another, they split the 3 points evenly, 1.5 and 1.5 points. Bowlers bowling against a blind bowler must beat their own average minus 10.
- 2) **Team game** (*4 points each game*)
- 3) **Team series with handicap** (*3 points*)

## #16 Season Schedule

31 Week season consisting of (2) 10-week thirds and (1) 9 week third followed by two weeks of playoffs. The winner of each third along with a wildcard team will make the playoffs.

*Notable Weeks:*

*09/08/2024 – Start of Season*

*01/19/2025 – No Bowling (House Tournament)*

*04/13/2025 - Final Week of Bowling & Season Ending Payouts*

## #17 Tie Breakers

A one game roll-off will determine the winner in the event of a tie for first place at the end of a third or a tie in a playoff match. All other ties will split the prize money.

## #18 Playoffs

A four-team, two-week playoff during the final two weeks of the season will be used to determine League Champion. The winner of each third will qualify for the playoffs. The team with the highest overall points won among all non-winning teams will qualify as a wild-card. Total points won during the season will be used to determine playoff seeding. A wildcard team will automatically be seeded lower than any team that won a third. An additional wildcard team will be added to the playoffs for each repeat winner of a third. If a team wins all three thirds, there will be 3 total wildcard teams added to the playoffs.

## #19 New Bowler Invitations

The officers and team captains must vote whether to invite a new bowler into the league. A bowler is considered new if his name is not found on the previous season's final average sheet. A special exemption to this rule may be granted for a bowler that was recently in the league but missed the most recent season due to injury, sickness, or other hardship. League management has the right to deny any applicant from entering the league, regardless of average or membership standing. No new bowler with a Standard USBC average greater than 220, *Challenge* average greater than 206 or *Sport* average greater than 191 within the previous 5 seasons will be permitted into the league. New bowlers with a sanctioned average greater than 215/201/186 in the previous 5 seasons will be subject to a Mandatory League Board majority vote prior to joining the league.

## #20 Practice Etiquette

To allow more total shadow balls to be thrown during the 15 minutes of practice, each bowler shall only throw 1 shot per practice attempt. Bowlers shall not rerack to get a new set of pins.

## #21 Pre-Bowling

Per USBC Playing Rule 117b, an entire team will be eligible to request to pre-bowl when unable to field a legal lineup on the regular scheduled date/time of bowling due to some of its bowlers participating in the USBC Championship events, state or local association championship tournaments or attending an annual meeting. Individual pre-bowling is not permitted.
